Subject: Filling up of the three posts of Controller of Explosives in the Bureau of Civil Aviation Security on deputation basis.

Applications are invited from eligible officers for filling up of three posts of Controller of Explosives (General Central Service Group 'A' Gazetted Non-Ministerial) in the Pay Band-3 (Rs. 15,600-39,100/-) with Grade Pay of Rs.6600/- on deputation basis in the Bureau of Civil Aviation Security (BCAS). The selected officer can be posted at BCAS Headquarters, Delhi or at any of the Regional Offices of this Bureau at Delhi, Kolkata, Chennai and Mumbai. The posts are to be filled up from the;

- (i) Officers of Police/Security Organizations of the Government of India;
- (ii) Officers of Para-Military Organizations of the Government of India;

Holding analogous posts on regular basis, with 5 years regular service in posts in the scale of Rs.8000-13500 or equivalent OR with 8 years regular service in posts in the scale of Rs. 6000-10500 or equivalent and

- (iii) Serving Armed Forces Officers in the rank of Captain/Major or equivalent;

Possessing the following Qualifications will be eligible for consideration.

Essential:

Experience of handling Explosives, etc including a minimum of three years experience in the detection and defusing/demolition of unexploded armaments and explosive devices.

Desirable:

- (i) Having undergone a recognized advanced course, relevant to the Essential Qualification e.g. Bomb Disposal Course at the Military College of Engineering Pune. And
- (ii) Experience of having served in Anti-Terrorist Organizations such as Commandos, Special Protection Group, National Security Guard etc.

2. Period of deputation will ordinarily be 3 years extendable by 1 year, if mutually agreed by the Borrowing and Lending Authorities.

Note: The maximum age limit for appointment by transfer on deputation shall not exceed 35 years as on the closing date of receipt of applications.

3. The period of deputation including period of deputation in another ex-cadre post held immediately preceding this appointment in the same or some other organization/department of the Central Government shall ordinarily not exceed five years. The maximum age limit for appointment by deputation/absorption shall not be exceeding 35 years as on the closing date of receipt of applications.

4. The selected officers will be governed by the terms and conditions of deputation laid down in the Ministry of Personnel, Public Grievances & Pensions (Deptt. Of Personnel and Training) O.M. No. 2/29/91-Estt. (Pay-II) dated 05-01-94 as amended from time to time read with Ministry of Civil Aviation's Policy letter No. CAS-10(1)87-HQ(SFS/IGRUA) dated 25.4.1988. They will have the option to either draw pay in the scale of pay applicable in the parent organization plus deputation allowance or have the pay fixed in the scale applicable to deputation post as per above OM.

- i. Vigilance Clearance Certificate
- ii. Integrity Certificate

- iv. ACRs dossier or ACRs for the last five years (It may kindly be noted that the Photostat copies of ACRs should be attested by an officer not below the rank of Under Secretary or equivalent on each page)
